CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive

bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

APPOINTMENT OF A QUALIFIED SERVICE PROVIDER TO SERVICE AND PROVIDE REPAIR WORK TO THE POWER GENERATOR AT NEDLAC

1. INTRODUCTION

The National Economic Development and Labour Council (Nedlac) is a statutory body that was established through Nedlac Act No. 35 of 1994 and operates under the terms of its own Nedlac Constitution. Nedlac's vision is to promote growth, equity and participation through social dialogue.

2. PURPOSE

- 2.1 Nedlac requires services of a reputable and experienced service provider with expertise in working on John Deere diesel powered generators, to provide service maintenance, as well as repair of John Deere diesel power generator at Nedlac for a period of 36 months (three years).

The objective of this exercise is to ensure reliable and sustainable operation of the power generator as well as uninterrupted provision of power supply to the Nedlac building during municipal and national power interruptions.

3. BACKGROUND

Nedlac has one office nationally with an employee compliment of +-37 and external stakeholders/social partners. Before the Covid19 pandemic, on average +- sixty people would use the facilities on a daily basis. The office is situated at 14A Jellicoe Avenue in Rosebank, Johannesburg.

4. SCOPE OF WORK

- 4.1 Nedlac requires services of a reputable and experienced service provider with expertise in working on John Deere diesel powered generators, to provide service maintenance, as well as repair and replacement of spares on the John Deere diesel power generator at Nedlac for a period of 36 months (three years).

- 4.2 The service provider is expected to do the following:

- a) perform inspections of the power generator as and when required;
- b) perform comprehensive servicing of the power generator once a year over a period of 36 months (three years). Servicing should also include the replacement of all consumables, replacement parts and related components;
- c) attend to emergency breakdowns of the power generator as and when required;
- d) perform maintenance and repairs of the power generator when required.

- 4.3 The details of the power generator are as follows:

Manufacturer: John Deere
Model No. 6068TF158

- a) Service provider to conduct a site visit prior to quoting.
- b) Service provider to issue Nedlac with warranty for work done and guarantee on spare part and related components installed.

5. TIMEFRAMES

The service provider to commence work immediately after appointment.

Following service intervals to take place during November of the following two years up to November 2023.

6. REQUIREMENTS OF THE SERVICE PROVIDER

6.1 The successful service provider must meet the following mandatory requirements:

- a) Be a registered entity with a minimum of three years' service experience in the service and maintenance of John Deere diesel generators (servicing diesel engines, overhauling diesel engines, servicing alternator/generator, electrical, instrumentation and mechanical controls for diesel generators).
- b) Be a trade tested diesel mechanic with a minimum of three years relevant work experience, which must include being responsible for conducting service repairs on John Deere diesel generators.
- c) Provide copies of CVs of trade tested diesel mechanics and certified copies of trade certificates, and relevant training certificates.
- d) Be registered with CIDB and should have a minimum CIDB contractor grading of 2EP / 2ME or higher.
