CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.

1.7 The purchaser reserves the right to require of a bidder, either before a bid is adjudicated

or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

2. DEFINITIONS

- (a) **“B-BBEE”** means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;
- (b) **“B-BBEE status level of contributor”** means the B-BBEE status of an entity in terms of a code of good practice on black economic empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- (c) **“bid”** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of goods or services, through price quotations, advertised competitive bidding processes or proposals;
- (d) **“Broad-Based Black Economic Empowerment Act”** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);

DRAFT TERMS OF REFERENCE

APPOINTMENT OF A QUALIFIED, EXPERIENCED, AND PROFESSIONAL SERVICE PROVIDER TO DOCUMENT THE NEDLAC DIALOGUE SERIES ON THE COVID19 PANDEMIC: LEARNING THE LESSONS, CREATING A LEGACY

1. BACKGROUND AND INTRODUCTION

- 1.1. Since March 2020, the social partners at Nedlac have engaged amongst themselves and with other stakeholders including the economic work stream of the NatJoints, set up to coordinate the government's response to ensure that the impact on both lives and livelihoods of the Covid19 pandemic was minimised.
- 1.2. The areas of engagement in the Nedlac Rapid Response Task Team (NRRTT), its sub-committees as well as the economic work stream of the NatJoints have included the following:
 - a) Balancing lockdown measures to prevent transmission of the virus with maintaining livelihoods, especially in tourism and event sectors;
 - b) Roll out of vaccines;
 - c) Management of Covid19 in the workplace;
 - d) Provision of income replacement to workers, relief to the unemployed, and support to businesses; and
 - e) Roll out of PPE including promoting local production.
- 1.3. Social partners have lobbied, negotiated, provided feedback, implemented, partnered, and exercised oversight with a high degree of consensus while the Covid19 virus has evolved and the scientific response has developed and shifted.

- 1.4. There is now a recognition that while there may be further pandemic phases, the Covid19 is now endemic and therefore the response to Covid19 needs to be integrated into a new normal, with general public health measures and occupational health and safety in place.
- 1.5. In this context, there is no longer a need for a Covid19 NRRTT, however, the Nedlac social partners have agreed to consider the lessons learnt and make proposals for the ongoing management of Covid19 as well where a legacy can be created.

2. PURPOSE

- 2.1. Nedlac requires a suitably qualified, experienced service provider with a good track record to document and provide a report on a series of four (4) dialogue sessions where Nedlac Social Partners will be:
 - 2.1.1. Winding down on the work of the Nedlac Rapid Response Task Team (NRRTT) as well as identify and allocate outstanding or ongoing work to other appropriate structures in or outside of Nedlac;
 - 2.1.2. Deliberating on and determining lessons learnt and highlighting proposals for the future, arising from the experiences of the NRRTT over the last two years.

3. SCOPE OF WORK

- 3.1. The service provider is expected to:
 - 3.1.1. Document four (4) sessions of the proceedings of the Nedlac dialogue series to assist Nedlac and its social partners in appropriately winding down on the work of the NRRTT and learning the lessons for the future.
 - 3.1.2. The four-dialogue series will cover the following thematic engagements and focus areas:
 - a) An external-facing dialogue series focusing on the **lessons learnt from the Covid19 for social contracting** arising out of the Covid19 pandemic [online-19 July 2022]
 - b) An external-facing dialogue series focusing on the **lessons learnt from the Covid19 for social partnerships** between social partners including the state arising out of the Covid19 pandemic [online-2 August 2022]
 - c) A **launch event for the Covid19 workplace health and safety management programme** which includes looking at the recent ILO

decision to elevate the importance of workplace occupational health and safety [online-16 August 2022]

- d) An **internal review meeting** of the NRRTT where the Covid19 programme of action is evaluated and where appropriate ongoing work is assigned to other structures in or outside of Nedlac [hybrid-30 August 2022]

3.1.3. The dialogue series events will take place over four (4) different days, over six (6) weeks.

3.2. The service provider will be expected to deliver the following:

- a) Provide a summary note on each of the four above-mentioned engagements (Recordings of the sessions that took place prior the appointment will be provided).
- b) Draft a draft report/s of the above-mentioned engagements, outlining the engagements and recommendations that may have been raised in the different engagements.
