CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:

Bid rigging is, therefore, an agreement between competitors not to compete.

or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

- (c) **“bid”** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of goods or services, through price quotations, advertised competitive bidding processes or proposals;

REQUEST FOR PROPOSALS FOR A SERVICE PROVIDER TO ASSIST NEDLAC IN RESPECT OF STRATEGIC AND ANNUAL PERFORMANCE PLANNING

1. INTRODUCTION

Nedlac is a statutory body which is required to develop a 5-year Strategic Plan and Annual Performance Plan (annually) as required by the government regulations.

The Nedlac secretariat is required to:

- Amend its Strategic Plan for 2020/21 – 2024/5 in line with changes to its role and mandate;
- Amend the Annual Performance Plan for 2023/24 to include the Presidential Climate Commission (PCC) as a new Programme of Nedlac;
- Update the Annual Performance Plan for 2022/23 including the PCC as a new Programme.

Due to the significant shifts that will be required, Nedlac seeks the assistance of a service provider to assisting in the drafting of the above three documents.

2. SCOPE OF WORK

The service provider is required to:

2.1. Facilitate the production of the following documents:

- a) Amended Strategic Plan (SP) for 2020/21 – 2021/25

- b) Amended Annual Performance Plan (APP) for 2022/23
- c) Annual Performance Plan (APP) 2023/24

2.2. The above will require the following:

- a) Reviewing the current Strategic Plan and Annual Performance Plan as well as the business plan of the Presidential Climate Commission (PCC).
- b) Facilitate two half day planning sessions with the management of Nedlac and the PCC;
- c) Consult with the relevant managers of Nedlac and the PCC;
- d) Develop the draft documents set out at 2.1. for submission to governance structures of Nedlac by beginning of October 2022;
- e) Liaise with the CFO and user departments to ensure that the costing associated with the APP is accurate and included in the amended 2022/23 budget and the 2023/4 budget.
- f) Drafting the final version after feedback from the governance structures by mid-December 2022.

2.2. In undertaking the above, the Service Provider will need to ensure that:

- a) The SP and APP are compliant with the Public Finance and Management Act and Regulations and any other relevant prescripts;
- b) The indicators meet the criteria set out in the Framework for Managing Programme Performance Information and Framework for Strategic Plans;
- c) Targets meet the Specific, Measurable, Achievable, Realistic, and Timely (SMART) principles;
- d) The Technical Indicator Descriptors meet the required standards; and
- e) The costs associated with the APP are in line with Nedlac's allocated budget.

3. REQUIREMENTS

3.1. The successful service provider must have;

3.1.1. A thorough working understanding and knowledge of the following:

- a) Constitution of South Africa;
- b) Public Finance Management Act of 1999 and Treasury Regulations;
- c) National Treasury Framework for Managing Programme Performance Information and Framework for Strategic Plans and Annual Performance Plans.

3.1.2. Previous experience of working with and in:

- a) Public entities in South Africa;
- b) Strategic and business planning;
- c) Costing and budgeting; and
- d) Reporting, monitoring and evaluation in a public sector organisation.

3.1.3. Significant experience in drafting of clear, simple and accessible documents.
