**CERTIFICATE OF INDEPENDENT BID DETERMINATION**

- 1 This Standard Bidding Document (SBD) must form part of all bids<sup>1</sup> invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).<sup>2</sup> Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:

or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

- (b) **“B-BBEE status level of contributor”** means the B-BBEE status of an entity in terms of a code of good practice on black economic empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- (c) **“bid”** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of goods or services, through price quotations, advertised competitive bidding processes or proposals;
- (d) **“Broad-Based Black Economic Empowerment Act”** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (e) **“EME”** means an Exempted Micro Enterprise in terms of a code of good practice on black economic empowerment issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act;
- (f) **“functionality”** means the ability of a tenderer to provide goods or services in accordance with specifications as set out in the tender documents.
- (g) **“prices”** includes all applicable taxes less all unconditional discounts;

### **REQUEST FOR QUOTATIONS APPOINTMENT OF A PROFESSIONAL CHOIR TO PERFORM MUSICAL ITEMS AT THE 27<sup>TH</sup> NEDLAC NATIONAL ANNUAL SUMMIT**

#### **1. PURPOSE**

Nedlac requires a service of an established choir to provide musical items during the 27<sup>th</sup> Nedlac National Annual Summit to be hosted on **09 September 2022**.

#### **2. BACKGROUND**

- 2.1 Nedlac is the vehicle by which Government, Labour, Business and Community formations seek to cooperate, through problem-solving and negotiation, on economic, labour and developmental issues as well as related challenges facing the country.
- 2.2. As mandated in the Nedlac protocol, Nedlac is required to host a national summit each year. The national summit is to be chaired by the Deputy President of the Republic of South Africa.
- 2.3. The function of the summit is to provide feedback on Nedlac's activities in a transparent manner, and to obtain inputs from organisations or persons not normally involved in the Nedlac structures and also to establish a broader ownership of council. Additionally, the annual summit provides a platform for the council to present an overview of the of the past year's activities.
- 2.4. A total of 250 people will be attending the summit at the venue and approximately 300 people will watch it online, through online streaming platforms.
- 2.5 The summit will be attended by high profile political leadership including the Deputy President, at least two Ministers or Deputy Ministers.

#### **3. SCOPE OF WORK**

3.1 The choir is expected to provide the following:

- 3.1.1 Musical items at the start and during intervals for a maximum period of +-6 hours (+-08h00-14h00).
- 3.1.2 Musical items to include South African vocals, local jazz and harmony items and may include the singing of the South African National Anthem.
- 3.1.3 Be an assemble of not more than fifteen (15) individuals/voices.
- 3.1.4 Be dressed in a uniform and professional "choir" manner.
- 3.1.5 Provide for its own transportation to and from the event venue.
- 3.1.6 Be available to showcase/sample their performance to the Nedlac staff prior to performing at the event.
- 3.1.7 Be available for rehearsal at the venue on the eve of the event.

#### **4. REQUIREMENTS OF THE BIDDER**

4.1. The choir must have been in existence for more than five years and performed at similar professional events.

4.2. The choir must provide the following:

- 4.2.1. A project proposal indicating how they would respond to the scope of work set out above.
- 4.2.2. A brief profile of the choir.
- 4.2.3. A video clip of the choir performances (performing South African vocals, local jazz and harmony songs).
- 4.2.4. A detailed cost out-line/quotation.
- 4.2.5. Point of contact including name, title, phone number and email address.

4.3. The following other documents required are:

- 4.3.1. Provide proof of registration on the Centralised Supplier Database (CSD report).
