- 1.6 Failure on the part of a bidder to submit proof of B-BBEE Status level of contributor together with the bid, will be interpreted to mean that preference points for B-BBEE status level of contribution are not claimed.
- 1.7 The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

APPOINTMENT OF A QUALIFIED SERVICE PROVIDER TO RE-PAVE EXTERNAL GROUNDS OF NEDLAC HOUSE

1. INTRODUCTION

1.1 The National Economic Development and Labour Council (Nedlac) is a statutory body that was established through the Nedlac Act No. 35 of 1994 and operates under the terms of the Nedlac Constitution. Nedlac's vision is to promote growth, equity and participation through social dialogue.

2. PURPOSE

- 2.1 Nedlac requires services of a reputable and experienced service provider with expertise in supply and installation of paving goods and services, to re-pave the external grounds of Nedlac House.
- 2.2 The objective of this exercise is to ensure the restoration and beautification of the Nedlac premises as well as preservation of the value of the property.

3. BACKGROUND

3.1 Nedlac has one office nationally with an employee compliment of +-fifty (50) staff members and external stakeholders/social partners. Before the Covid-19 pandemic, on average +- sixty (60) people would use the facilities on a daily basis. The office is situated at 14A Jellicoe Avenue in Rosebank, Johannesburg.

4. SCOPE OF WORK

- 4.1 Nedlac requires services of a reputable and experienced paving services provider to perform the following:
- a) Inspect current paving bricks and supply same if not similar brick pavers, for re-paving;
 - b) Remove current brick pavers and lay out all areas to be re-paved;
 - c) Excavate the soil and perform all required ground levelling techniques for ground preparation prior to re-paving, including the installation of a weed barrier;
 - d) Install and level brick pavers, including edging brick pavers, in all external grounds that require paving;
 - e) Provide all required products and equipment;
 - f) Supply and install concrete rain water channelling, where channelling of rain/drainage water is required;
 - g) Supply and install materials/products that comply with the requirements of SANS 1058;
 - h) Ensure use of quality industry approved and SABS approved brick pavers for high traffic areas.
- 4.2 Service provider to conduct a site visit prior to quoting.

Site visit to take place at Nedlac House, 14A Jellicoe Avenue, Rosebank on Monday 10 October 2022 at 11h00-12h00, 13h00-14h00 and 14h30-15h30. Please ask for Sam or Sharlotte.

- 4.3 Service provider to issue Nedlac with warranty for work done and guarantee on products used/installed.

5. REQUIREMENTS OF THE SERVICE PROVIDER

- 5.1 The successful service provider must meet the following mandatory requirements:
- 5.1.1 Be a registered contractor for supply and installation of brick paver for commercial buildings.
 - 5.1.2 Be a member of the ICPI (Interlocking Concrete Paver Institute) and/or Construction Industry Development Board (CIDB) and/or Master Builders Association.

- 5.1.3 Provide proof of accreditation by the ICPI (Interlocking Concrete Paver Institute) and/or Construction Industry Development Board (CIDB) and/or Master Builders Association.
- 5.1.4 Have relevant years of work experience in the field of supplying and installing brick pavers for commercial properties.
- 5.1.5 Have a competent team that will be dedicated to this project.
- 5.1.6 Provide Nedlac with a project plan outlining the project deliverables timelines.
- 5.1.7 Provide certified copies of trade certificates related to the requirements of the project.
- 5.1.8 Provide at least five (5) signed reference letters and contactable references for similar projects completed in the last five (5) years.
- 5.1.9 Provide a company profile.
