**APPOINTMENT OF A SERVICE PROVIDER TO REPAIR AND SERVICE THE JOJO  
TANK & STORM WATER PUMP FOR THE NEDLAC BUILDING**

**1. INTRODUCTION**

1.1 The National Economic Development and Labour Council (Nedlac) is a statutory body that was established through Nedlac Act No. 35 of 1994 and operates under the terms of its own Nedlac Constitution. Nedlac’s vision is to promote growth, equity and participation through social dialogue.

**2. PURPOSE**

2.1 Nedlac has a JOJO tank whose purpose is to provide the Nedlac building with water for ablution and non-consumption/drinking purposes during water cuts/disruptions as well as a storm water drainage pump that disposes of rain and surface water from the site. A suitably qualified and experienced technician/plumber is therefore required to service the JOJO and the storm water drainage pump over a period of 36 months (3 years) and attend to repairs as well as supply related spares/components (as and when needed). The storm water drainage pump needs to be repaired and then serviced on an annual basis for 36 months.

**3. BACKGROUND**

3.1 Nedlac has one office nationally with an employee compliment of +-50 and external

stakeholders/social partners. Before the Covid19 pandemic, on average +- 60 people would use the facilities on a daily basis. The office is situated at 14A Jellicoe Avenue in Rosebank, Johannesburg. The building consists of three floors and a basement parking area.

#### 4. SCOPE OF WORK

- 4.1 Assess the current operation of the JOJO, accessories, compressor and storm water drainage pump.
- 4.2 Repair the storm water drainage pump and ensure full operation of the pump.
- 4.3 Check and ensure full operation of all JOJO tank spares and compressor.
- 4.4 Sanitise and service the JOJO tank annually over a period of 36 months.
- 4.5 Attend to repairs of the JOJO tank and storm water drainage pump **as and when needed** and supply all required spares for repairs.
- 4.6 Check and ensure that the JOJO tank automatically relays water to the Nedlac building during water cuts/disruptions.
- 4.7 Manage the water storage/disposal process and accessories during sanitation and servicing intervals.
- 4.8 Service provider/s to conduct a site inspection prior to quoting. **Site visit to be conducted as follows: Friday 11 November & Monday 14<sup>th</sup> November 2022 from 10h00 – 15h00 at Nedlac House 14A Jellicoe Avenue, Rosebank**
- 4.9 Service provider/s to issue Nedlac with guarantee/warranty certificates for work done and equipment/spare parts installed.

#### 5. REQUIREMENTS OF THE SERVICE PROVIDER

- 5.1 The successful service provider must meet the following mandatory requirements:
  - 5.1.1 Have experience and professional understanding of plumbing, piping, automation of bulk water storage and water irrigation systems as well as storm water drainage pump systems.

- 5.1.2 Have experience and professional understanding of installing and servicing bulk water storage systems.
- 5.1.3 Have experience and professional understanding of repairing and servicing storm water drainage pumps.
- 5.1.4 Have traceable experience in sanitising of bulk water storage systems.
- 5.1.5 Be an accredited plumber and a JOJO tank installer (show an up to date accreditation card/confirmation).
- 5.1.6 Use SABS approved products.
- 5.1.7 Have a competent team that will be dedicated to this project.
- 5.1.8 Provide Nedlac with a project plan outlining the project deliverables timelines.
- 5.1.9 Provide certified copies of trade certificates related to the requirements of the project.
- 5.1.10 Provide five (5) contactable and formal (on letterhead) references for similar projects completed in the last five years.
- 5.1.11 Provide CVs of project staff and a company profile.

## **6. SUBMISSION OF DOCUMENTS**

- 6.1 In addition to the requirements of 5.1 above, service providers must submit the following documents:
  - 6.1.1 Detailed budget indicating the maximum amount for the project.
  - 6.1.2 Proof of CSD registration.
  - 6.1.3 Completed SBD forms.
  - 6.1.4 Valid BBBEE certificate or sworn affidavit.
