- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

TERMS OF REFERENCE

APPOINTMENT OF A SERVICE PROVIDER TO SERVICE AND PROVIDE REPAIR WORK TO THE POWER GENERATOR AT NEDLAC

1. INTRODUCTION

The National Economic Development and Labour Council (Nedlac) is a statutory body that was established through Nedlac Act No. 35 of 1994 and operates under the terms of its own Nedlac Constitution. Nedlac's vision is to promote growth, equity and participation through social dialogue.

2. PURPOSE

- 2.1 Nedlac requires services of a reputable and experienced service provider with expertise in working on John Deere diesel powered generators, to provide service maintenance, as well as repair to John Deere diesel power generator at Nedlac House for a period of 36 months (three years).

The objective of this exercise is to ensure reliable and sustainable operation of the power generator as well as uninterrupted provision of power supply to the Nedlac building during municipal and national power interruptions.

3. BACKGROUND

- 3.1 Nedlac has one office nationally with an employee compliment of +-57 employees and external stakeholders/social partners. The Nedlac office is situated at 14A Jellicoe Avenue in Rosebank, Johannesburg.

4. SCOPE OF WORK

- 4.1 The service provider is expected to provide the following services:
- a) Assess the performance of the power generator and provide an assessment report with recommendations;
 - b) Attend to repairs of the power generator;
 - c) Perform comprehensive servicing (major service) of the power generator once a year over a period of 36 months (three years). Servicing should also include the replacement of all consumables, replacement parts and related components;

- d) Perform quarterly minor service of the power generator over a period of 36 months (three years). Servicing should also include the replacement of all consumables, replacement parts and related components;
- e) Perform monthly inspections of the power generator;
- f) Attend to emergency repairs of the power generator as and when required;
- g) Issue Nedlac with warranty for work done and guarantee on spare part and related components installed/used.

4.3 The details of the power generator are as follows:

Manufacturer: John Deere
Model No. 6068TF158
Power Capacity: 100KW

5. REQUIREMENTS OF THE SERVICE PROVIDER

5.1 The successful service provider must meet the following mandatory requirements:

- a) Be a registered entity with a minimum of five years' experience in the servicing and maintenance of John Deere diesel generators. This to include experience in servicing diesel engines, overhauling diesel engines, servicing alternator/generator' electrical instrumentation and mechanical controls for diesel generators.
- b) Be a trade tested diesel mechanic with a minimum of five years relevant work experience, which must include being responsible for conducting service repairs on John Deere diesel generators.
- c) Provide proof of qualification related to working on John Deere diesel power and other diesel generators.
- d) Provide a detailed service/maintenance plan specific to this project.
- e) Provide proof of a minimum of five (5) years' experience in the maintenance and servicing of diesel power generators.

- f) Submit proof of a minimum of five (5) similar projects with client name, description of the project, value of contract, period which the project was performed, reference letters and contact details of the clients.
- g) Provide proof of up-to-date CIDB contractor grading of 1EP or higher.
- h) Provide an up-to-date letter of good standing with COIDA.
- i) Provide certified copies of trade certificates related to the requirements of the project.
- j) Have a qualified and competent team that will be dedicated to this project.

6. SUBMISSION OF DOCUMENTS

6.1 In addition to the requirements of 5.1 above, service providers must submit the following documents:

6.1.1 Proof of CSD registration.

6.1.2 Completed SBD forms.

6.1.3 Valid BBBEE certificate or sworn affidavit.

7.2.3 Nedlac reserves the right to cancel this bid or ultimately decide not to appoint any service provider in terms of this call for quotations.

7.2.4 Service providers must be ready and available to commence work immediately after appointment.

9. PAYMENT TERMS

9.1 Payments will be made within 30 days from receipt of invoice and against presentation of satisfactory deliverables as will be agreed upon on appointment of the successful bidder/service provider.

10. CIDB REQUIREMENTS

- “It is estimated that tenderers must have a CIDB contractor grading designation of 1EP or higher”
- “Only those tenderers who are registered with the cidb, or are capable of being so prior to the evaluation of submissions, in a contractor grading designation equal to or higher than a contractor grading designation determined in accordance with the sum tendered, or a value determined in accordance with Regulation 25 (1B) or 25(7A) of the Construction Industry Development Regulations, for a 1EP Or higher class of construction work, are eligible to have their tenders evaluated.

Joint ventures are eligible to submit tenders provided that:

1. every member of the joint venture is registered with the cidb;
2. the lead partner has a contractor grading designation in the 1EP or higher class of construction work; or not lower than one level below the required grading designation in the class of works construction works under considerations and possess the required recognition status.
3. the combined contractor grading designation calculated in accordance with the Construction Industry Development Regulations is equal to or higher than a contractor grading designation determined in accordance with the sum tendered for a 1EP or higher class of construction work or a value determined in accordance with Regulation 25 (1B) or 25(7A) of the Construction Industry Development Regulations.
